Tuition Payment Policy

With each returned Enrollment Contract, tuition is due under option (a) or (b) or (c) or (d) as described below:

Option (a) Tuition Due by May 15th

Option (b) Tuition made in 2 payments:

Initial payment due by May 15th plus an administration fee with the 2nd payment due August 15th

Please note that Option (c) and (d) are only available if your account has been in good standing within the last 12 months or upon the approval of the Board of Directors.

Option (c) Tuition made in 5 payments.

Initial payment due by May 15th plus an administration fee with 4 additional payments due June 15th, September 15th, October 15th, and November 15th.

Option (d) Tuition made in 10 payments.

Initial payment is due May 30st plus an administration fee with 9 additional payments due on the 30th of the months of June, July, August, September, October, November, December, January and February 28th.

Post dated cheques must be enclosed when Enrolment Contracts are returned.

Child Care Tax Receipts will be issued for 21% of Tuition paid for students in Grades 1 to 8 in January for the preceding twelve months and Receipts for students in all Pre-Grade 1 programs will be issued for 100% of Tuition paid.
